- Carry out soil investigation works required to implement the proposed task.
- Carry out the feasibility study for potential area of the task implementation.
- Carry out detail potentiality survey of the proposed lab establishment and seed breading lab.
- Establish Tissue culture laboratory applied for Potato seed and other fruits/vegetables.
- Propose the expected value of the economical benefit in terms of the profit of lab operation, seed selling and technology transfer.



2.Instruction of Applicants

2.1 Introduction

2.1.1 Scope of Qualification

The Rural Municipality intends to select competent public or private sectors (Person, firms, banks, financial institutes, cooperatives, NGOs etc) or their JV for **implementation of above proposed tasks.** Invitation of Expression of Interest (EoI) is made to invite application from interested and eligible public and private sectors or their JV.

2.2 GENERAL INSTRUCTION TO APPLICANTS

2.2.2 Amendment to EoI Documents

At any time prior to the deadline for the submission of the completed EoI document, Rural Municipality Office may amend the EoI, for any reason, whether on its own initiative or in response to a clarification requested by an applicant. Amendments will be notified through website: www.guransmun.gov.np. The Rural Municipality will assume that the information contained in the amendment is taken into account by the Applicant in its Application.

2.2.3 Confidentiality of the Document

If an Applicant believes that any portion of the submittal is to be treated in confidence, he/she shall identify such information clearly in the submittal. The Rural Municipality will make every effort to treat such documents in confidence as far as possible.

2.2.4 Joint Venture and Joint Liability for Joint Venture Firms

Applicant/firms can form a Joint Venture (JV) with **maximum three partners**, but an applicant/firm is not eligible to submit more than one EOI either as a single applicant/firm or as a member of a JV. Failing this the EOI of such applicant/firm(s) shall be rejected. The EOI must clearly mention the name of the leading applicant/firm.

Submitting an EoI in joint venture (JV) will be understood as the Applicant represents that, if qualified and if awarded the contract after the process, the Applicant with its constituent members shall be jointly responsible to perform the obligation of such contract.



2.3 SUBMISSION OF EoI

2.3.1 Sealing and Marking

- 1. The applicant shall seal the one original and one copy of the completed EoI in separate envelopes, duly marking the envelopes as "ORIGINAL" and "COPY". These envelopes shall then be sealed in an outer envelope and marked as "Expression of Interest". The inner as well as outer envelope shall clearly mention the Job number and title of consulting job.

2.3.2 Deadline for Submission and Opening of EoI Document

- 1. The EoI document can be received till 15th day from publication of notice. The EoI document can be submitted till 12 Noon of 16th day from publication of notice.
- 2. The EoI document will be opened on 16th day from date of publication of notice at 14:00 hour at the Rural Municipality office in presence of the applicants or their authorized representative who-so-ever wish to attend. Absence of representative of applicants will not obstruct or prevent the EoI opening in any way. Applicants' each designated representative must bring a letter from the applicant stating that he/she is authorized to represent the applicants for the public opening of the EoI document.
- 2. If the deadline specified herein falls on a government holiday, the deadline shall be extended automatically to the next working day at the same hour.

2.4 Evaluation Process

The Rural Municipality will carry out evaluation of the EoI documents based on the criteria approved by this office which are mentioned below in the ToR. Anything not mentioned in this document regarding EoI process shall be governed by the prevailing laws of Nepal. The evaluation of EoI documents will be done in two stages as mentioned in ANNEX II.

2.5. No Separate RFP

The EoI also covers the technical as well as financial proposal for the stated task. So no further RFP will be published for the qualified applicants. The Quality and Cost Based Selection (QCBS) procedure will be used for final selection of the consulting firm.

2.6 Clarification during Evaluation by Rural Municipality



- 1. During the evaluation, Rural Municipality may request the applicant for necessary clarification. The applicant shall furnish the necessary clarification expeditiously by post/currier/fax/email or by any other means of communication to the office of Rural Municipality at the address mentioned in notice.
- 2. Failure to provide information, essential clarification or to provide timely clarification or substantiation of the information furnished, Rural Municipality would be at liberty to declare such applicant as non-responsive and reject the document.

2.7 Rejection of EoI document of Applicant
